Week Review

30 Day Notice Discussion:

- 30 Day Notice needs to go out to inform membership of meeting in May. Agenda, Rule Proposals, Elections.
- Show Bidding- Membership needs to be informed of Show Bidding for 2018.
- WGASC E-Committee is working to formulate a New Show Selection Process. The current model is not working for WGASC or for show host themselves. Attendance is declining at shows in both units attending and spectators at some sites.. This has a financial effect on the host as well.
 - This is mainly due to a Calendar/Scheduling Issues. WGASC is choosing shows before the WGI schedule is posted.
